**Available**

To all members for farm and domestic uses, except those accounts who are submetered, net-metered, have co-op owned water heaters, are participating in our opt-out metering option, and/or enrolled in our demand response programs.

**Type of Service**

Single-phase, 60 hertz, at available secondary voltage.

**Adder**

**Minimum Monthly Charge**

The minimum charge shall be the highest of the following:

1. The distribution monthly grid access charge:

**Determination of Billing Demand (non-coincident peak demand)**

The billing demand shall be the maximum kilowatt demand established by the member for any period of fifteen consecutive minutes during the month for which the bill is rendered, as indicated or recorded by a demand meter.
